



1. The words "Quotation of Purchasing and repairing of Musical Instruments" of Delhi Police Public School, B-4, Safdarjung Enclave, New Delhi should be mentioned at the top of the envelope. The same should be addressed to, The Principal, Delhi Police Public School, Safdarjung Enclave, New Delhi-110029.
2. The quotation received after scheduled time/date shall not be entertained.
3. Conditional quotation will not accepted.
4. The rates should include GST as applicable.
5. The rate of each item especially repairing work and new instruments should be mentioned separately, if possible.
6. The vendor must be registered with GST and registration certificate for the same must be attached with the quotation.
7. No advance payment shall be made at any cost.
8. Payment shall be release only after satisfactory report of the committee appointed by the school.
9. **The price quoted by the vendor should include the transportation delivery as well as installation charges or any other hidden charges. Hence, it will be responsibility of the vendor to transport, delivery and installation the musical item at his own cost. No extra payment shall be made to vendor in this regard. No payment shall be released if the quantity is not found as per given above.**
