
1. An auction of the following condemned School buses belonging to Police Foundation for Education, Delhi on as is where basis is is being carried out.

5. Interested person can inspect the vehicle on any working day between 10.30 am to 4.00 pm. in Delhi Police Public School, B-4, Safdarjang Enclave , New Delhi premises.
6. The auction will be governed by the following conditions:-
 - (i) The successful bidder will be required to deposit the balance bid amount after deducting earnest money of Rs.10,000/- latest within one week of intimation about successful bidder, by way of Demand Draft in favour of Police Foundation for Education, Delhi.

- (ii) The delivery of the sold condemned vehicle will be given only to the successful H-1 bidder after submission of documentary evidence in support of residential status (Ration card /Voter Identity card / Adhar Card in case of individual and Registration Certificates in case of firms etc.).
 - (iii) The sold condemned vehicle shall have to be removed by the successful bidder immediately at his own expenses from the office premises, with a week's time.
 - (iv) The condemned vehicle will be disposed off " as is where is basis" and no guarantee for its worthiness or quality will be given by the PFED.
 - (v) The successful bidder shall not be allowed to withdraw his bid, failing which his earnest money will be forfeited.


