TERMS AND CONDITIONS OF THE TENDER FOR THE AWARD OF ANNUAL CONTRACT FOR HIRING OF CNG BUSES BY DELHI POLICE PUBLIC SCHOOL, SAFDARJANG ENCLAVE, NEW DELHI.

1. Sealed tenders are invited for hiring of 14 Nos. CNG Buses having seating capacity of 47/ 52 persons for ferrying students for Delhi Police Public School for a period of one session on regular basis for ferrying students so as to reach to this office on or before 1.00 PM. on the prescribed proforma (copy enclosed).
2. The Bidders are advised to study the terms and condition of Tender thoroughly .
3. The contract shall be for session ending Mid May, 2019 and the contract can be extended till the finalization of new Contract, with the approval of competent authority.
4. The tender terms and conditions/tender document are also available on Delhi Police Public School website i.e. [www. Delhipolicepublicschool.com](http://www.Delhipolicepublicschool.com). The firms which are dealing in the trade can also download the terms and conditions from the website and participate in the tender.
5. Separate envelopes should be used for TECHNICAL BID and for Financial BID.
6. The word “TECHNICAL BID/ Financial BID FOR THE AWARD OF ANNUAL CONTRACT FOR HIRING OF BUSES” may be super scribed. Both these sealed covers may be put in a bigger cover which should also be sealed and duly super scribed.

7. The Bus Vendor/ Contractor shall provide 3 complimentary Trips free of cost for Picnic / execution purpose for students in Delhi and NCR area upto maximum distance of 50 Kms one way. The Contractor shall not charge any amount for the said trip.
8. The Tender notice for hiring of sixteen routes ply out of which two school own buses will be plying on any route as decided by the Committee, for that route no claim/ right/ protest for awarding contract by any firm for not plying bus for such route are not admissible.
9. The Technical Bid will be opened first on the same day at 2.00 p.m on by the Tender Committee, Delhi Police Public School, S.J.Enclave, and New Delhi. The Financial Bid will be opened after scrutiny of technical bid. The Financial Bid of only those firms will be opened who qualify in technical bid and the scheduled date & time which will be fixed by the Purchase Committee.
10. The tendering firm will have to submit application fees @ Rs. 500/- (Non-refundable) in the shape of A/c Payee Demand Draft in favour of Delhi Police Public School, S.J.Enclave, New Delhi at the time of submission of tender, if tender is downloaded from the web-site. In case the firm fails to attach the draft of application fees, the tender shall be rejected.
11. The tender of those firms will be entertained who deposit the Earnest Money Deposit of Rs. 10,000/-per Bus in the shape of A/c Payee Demand Draft, FDR, Banker's cheque, Bank Guarantee in an acceptable form in favour of Delhi Police Public School, S.J.Enclave, New Delhi payable at Delhi towards Earnest Money without which tender will not be considered. The minimum No. of The bid security/EMD offered by the bidder will indicate number of buses (CNG Buses) offered for hiring by a bidder. No interest is payable on EMD amount and the EMD should be valid for 45 days beyond the bid validity.

12. Bid Security/EMD offered by the bidder will indicate Nos. of CNG Buses to be offered by the bidder.
13. The earnest money will be forfeited in following conditions: -
 - a) If at any stage any of the information/declaration given by the bidder is found false.
 - b) If a bidder withdraws his bid during the period of bid validity specified in the tender's terms & conditions.
 - c) In case of any lapse/default in honouring the terms & conditions at any stage after submitting the tender.
 - d) In case of final selection of bidder, if he fails to furnish Security Deposit in accordance with tenders terms & conditions.
14. The firm whose tender is accepted will have to deposit Security Money @ 5% of the annual contract amount in the shape of A/C Payee Demand Draft, FDR, Bank Guarantee in favour of Delhi Police Public School, S.J.Enclave, New Delhi within one week from the date of receipt of offer letter by the successful bidders, failing which earnest money deposited will be forfeited and offer will be cancelled. The decision of the Tender Committee will be final in this regard. The action regarding blacklisting of the firm can also be taken. Security Money shall bear no interest.
15. The Security Money should be valid to cover the entire period of the contract plus (2) months. The contract will be signed only after deposit of the Security Money.
16. The tenderer must quote rates clearly without any over-writing/cutting etc. inclusive of all taxes, if any
17. No advance payment will be made.
18. The Purchase Committee reserves the right to check the vehicles (Bus at premises) of the firms to judge its existence, suitability and capacity of the firm.

19. The Purchase Committee reserves the right to award the contract to one or more firms, on different routes in case the offered L-1 rates are found to be the same.
20. In case two or more bidders quote the same rates and are declared as L-1, the Tender Committee decision will be final for awarding the contract.
21. The firms whose rates are accepted will have to deposit a stamp paper worth Rs. 100/- for signing the agreement.
22. The Purchase Committee reserves the right to reject any or all the tenders without assigning any reasons.
23. No firm which has either been **blacklisted** by Delhi Police Public School or Delhi Police or by any other Govt. organization shall be allowed to participate in the tender process. All intending firms shall be under obligation to inform in writing about criminal cases pending against them (including Directors, Managing Directors, Managing Partners and Managers who may be authorized to look after their work), if any. The bidders shall also furnish names and residential address of their Directors, Managing Directors, Managing Partners and Managers. The Delhi Police Public School, S.J.Enclave, New Delhi shall get the antecedents of all such persons verified through any agency in respect of the **successful bidder only after finalization of the tender process.**
24. The individual/companies which have been **blacklisted** or against whom **criminal cases** have been registered and are pending investigation / trial or have ended adversely against the party concerned pertaining to the supply of vehicles during the period in which they have been awarded contracts by the DPPS to supply vehicles in the past, shall not be considered for awarding the contract if they are directly or even indirectly associated with the company making a bid in response to the tender.
25. The tender should be submitted in a sealed cover marked “**TENDER FOR HIRING of CNG BUSES**” for use in Delhi Police Public School,

S.J.Enclave, New Delhi” addressed to the Principal, Delhi Police Public School, S.J.Enclave, New Delhi and dropped in the tender box kept outside the office of the undersigned at Delhi Police Public School, S.J.Enclave, New Delhi. No tender will be accepted by hand. The tender document can also be downloaded from website i.e. www.delhipolicepublicschool.com.The number of vehicles can vary from time to time depending upon the requirement of vehicles.

26. The tender will also specify the condition of each CNG buses i.e. **MODIFIED CNG BUS OR NEW CNG BUSES** in their fleet furnished in their tenders.
27. Bidders are advised to study the tender documents, terms & conditions carefully. Submission of tender shall be deemed to have been done so after careful study & examination of tender documents.
28. The tender document can be obtained from this office at the cost of Rs. 500/- in cash or in the shape of A/c Payee Demand Draft in favour of DPPS/S.J.Enclave. The application fee is not refundable.
29. The tender document is not transferable.
30. The tenderer or their authorized representatives may be present at the time of opening= if they so desire. The bidders / representative who remain present will sign the attendance sheet in token of having attended the proceedings.
31. **The validity of the tender / rates should be for a period of one session or till the finalization of the awarding of the new contract.**
32. That the contractor shall be responsible for the antecedents of all drivers employed/hired by them for duty with Delhi Police Public School, S.J.Enclave, New Delhi . The contractor shall not change the drivers other than those listed without the permission of Principal/ Delhi Police Public School, S.J.Enclave, New Delhi. The Principal/ DPPS /S.J.Enclave will get

the verification of antecedents of the drivers done through any agency or other related security agencies, if needed be at Transporter's expenses. The drivers must be smartly turned out while on duty and must possess valid commercial driving license.

33. The contractor will be required to submit list of the vehicles along with photocopies of their R.C. as well as written confirmation from the owner of the respective vehicles, other than those owned by the tenderer, that these will be attached to the tendering firm. The Buses must be registered in Delhi only and must have all valid documents to ply in Delhi.
34. The Delhi Police Public School, S.J.Enclave or Delhi Police word/Logo/symbol should not be displayed on the hired vehicles. However, contractor can put a movable board on the hired vehicles bearing word "**ON SCHOOL DUTY**" while on duty. No fixed signage be displayed.
35. In case of breakdown of bus, it shall replace the breakdown vehicles from standby reserves the contractor shall be under obligation to provide another vehicle from standby vehicle within one hour time, failing which Delhi Police Public School, S.J.Enclave, New Delhi has the right to hire vehicle from any other sources at the expense of the contractor.
36. The contractor shall be solely responsible for arranging sufficient fuel to the vehicles supplied by him.
37. The contractor who have provide the CNG Buses for school duty shall produce the buses for inspection for the purpose of verification and fitness testing by the staff of Delhi Police Public School, S.J.Enclave, New Delhi .
38. The vehicle CNG which will be supplied by the successful tenderer or should be registered with STA, Delhi only. Necessary entries of the same must be available in RC of the vehicles. The vehicles supplied should be mechanically fit. The firm should be situated in NCT of Delhi area having proper office, telephone facility etc.

39. During deployment if the activities, movements, utterances, behavior etc. of the driver(s) are found to be suspicious or questionable or against the directions of Delhi Police Public School, S.J.Enclave, New Delhi , then the contractor will replace the driver from such duties by providing other driver immediately.
40. The Delhi Police Public School, S.J.Enclave, New Delhi will not be responsible for any damage to the hired vehicles due to any accident, fire and natural calamities or any unforeseen circumstances. In any circumstances when the hired vehicles is involved in any accident resulting to loss or damage to property or life with respect to the vehicle, driver or third party, the responsibility for any legal or financial implications shall rest solely with the contractor/owner of the hired vehicle. The DPPS shall have no liability whatsoever.
41. The contractor shall be responsible to furnish a copy of certificate of fitness and insurance of the vehicle from the competent authority.
42. The speedometer of each vehicle shall be properly sealed under the seal of the technical team of Delhi Police Public School, New Delhi after the first inspection itself. The vehicle's fleet shall be subject to surprise inspection. The contractor shall ensure that the drivers do not tamper with the seal of the vehicle and that they maintain all the paper properly. If the speedometer of any vehicle is found defective or out of order, the same should be repaired within 24 hours under intimation to DPPS.
43. The period of contract will be counted from the date of agreement with the successful bidders. However, the formal approval for extension of the contract for specific period will be obtained from competent authority at least 30 days in advance before the expiry of the contract.
44. The DPPS reserves the right to negotiate with the lowest tenderer firm for supply of vehicles. The right to accept / reject any tender without assigning any reasons is reserved by the DPPS.

45. In case the contractor fails to provide the requirement of vehicles within specified time, or if the contractor fails to provide required number of vehicles as per supply order, the contractor shall be liable to pay a penalty of Rs. 1500/- per day per vehicle over and above other expenditure incurred by the DPPS in order to perform the duty in addition to written warning in the first instance. One month notice shall be issued for cancellation of contract in the second instance and the contract shall stand cancelled in the third instance and Contract Performance Bank Guarantee will be forfeited without further notice.
46. It will be discretion of the Tender Committee to make any inquiry in order to judge the existence, capability and soundness of the firm.
47. Income Tax to be deducted at source at the prescribed rate of Govt. of India in all cases of payment to the contractor.
48. Incomplete or conditional tender will not be accepted.
49. DPPS reserves the right to terminate the contract at any time before expiry of the contract period without assigning any reasons by giving one month notice.
50. Each tender documents shall be signed either by all the partners of the firm or by a partner having authority on stamp paper (duly attested) on behalf of the firm to enter into the proposed contract.
51. The drivers deputed for School duty should not be addict to drugs and smoking.
52. As a token of acceptance of terms & conditions, a copy of the same duly signed by the bidders should be enclosed with their bids.
53. The driver(s) should be well aware of all traffic rules and should not be colour blind.

54. The contractor will have to provide the replacement of driver in case of any eventuality.

55. All disputes are subject to the jurisdiction of courts in the National Capital Territory of Delhi.

GENERAL INSTRUCTINS FOR THE BIDDERS

1. The main condition of running buses on school routes is that all the operators will adhere to abide by the directions of the Supreme Court (elaborate instructions issued by the Hon'ble Supreme Court in W.P. (Civil)13029 of 1985) for Schools Located in the National Capital. As also conveyed by Deputy Director of Education, Distt. South West (B), New Delhi in its communication No. F.DE/ACT/2011/2641-52 dated 18.5.2011 and permit conditions vide Directorate of Education, GNCT of Delhi order No.F.DE/15 (173)/Act-I/Part/2013/7985-99. The Contractor has agree to meticulously implement all such requirement irrespective of the fact that any such clauses is appearing in this agreement or not and any other directions by the Hon'ble Supreme Court of India hereafter.
2. The Bus must be in possession of a permit (Registration Certificate) issued by competent authority to operate as "Passenger Transport Vehicle ".
3. The buses provided should be mechanically sound (fitness certificate to this effect will be submitted act time of signing of contract) not more than 10 years old.
4. The bus must display prominently " On School duty" and also Telephone number of School and / or telephone number of any person shall also have to be written prominently a prominent place on each school bus so that in an emergency public can inform the school authority / police or other authorities.
5. The bus must have space fitted under the seat for children to keep their bags safely.

6. The bus should be fitted with GPS to enable tracking of the bus and keeping it always in working conditions the responsibility of the bus owner, the serviceability of GPS has to be certified by the Authority authorized to do the same. The bus must also have two CCTV installed, in the bus, per Govt. guidelines.
7. Each bus should carry a suitable photography of the authorized driver duly certified by the RTA /Transport provider.
8. All the buses provided by the transport Provider will be duly insured for third party risk and in case of any accident or damage it will be his sole responsibility to pay compensation to the claimants and the school will not responsible for any payment or for other violations. A copy of the Insurance policy, for each bus, will be provided by the Transport Contractor to the School management at the time of signing of the contract.
9. All CNG buses should undergo safety checks quarterly and annually as prescribed by law and this will be the responsibility of the Transport Provider who will provide proof to the school of having carried out the testing and the bus having been certified as FIT.
10. The buses provided by the contractor should be roadworthy and comfortable and be in all respects fit for the purpose(s) under this agreement. The contractor shall ensure that the drivers shall be in possession of valid license and badge, as applicable under law, and amended from time to time.

GENERAL CONDITIONS GOVERNING THE EXECUTION OF THE CONTRACT.

1. In the event that the contractor's buses do not strictly follow the time schedule specified by the school, the school shall deduct a sum of Rs.500/- (five hundred only) for each infringement / violation of the same from the amount due and payable to the contractor.
2. The contractor agrees that each bus shall have a duly licensed conductor in addition to the duly licensed drivers who shall both be the employee of the contractor. It shall be the duty of the driver and conductor of each bus to ensure that the students are properly seated and to help the student in boarding and alighting from the bus. It shall be the duty of the driver and conductor not to leave students at their designated stops unless a parent or relative is there to receive them.
3. It is agreed that the driver and conductor assigned to a particular route shall not be changed without the consent of the school after prior notice of not less than 24 hours. The reason for changes of driver / conductor should be clearly communicated to the competent authorities.
4. Only authorized conductor and driver who are license holders and possess an "authorization card", which will be provided by the transport department, will be allowed to operate school buses.
5. No bus will carry excess of the permitted strength of the students.
6. The drivers or the contractors while plying the buses will not allow any person other than students or teaches of the school to travel in the uses assigned on the routs for the school. It is understood by you that your Driver and conductor are responsible for the safe

- journey of the children in the bus. They should be polite, courteous and affectionate towards the children, staff and parents. In case of misconduct on their part the school authorities shall hold you responsible.
7. The contractor shall issue identity cards to each driver and conductor, which they shall possess at all times during the performance of their; duties under this agreement.
 8. Other instructions issued from time to time by transport authority or any law-enforcing agency will be strictly followed /adhered to.
 9. This agreement is terminable at the option of the school by serving one calendar month notice in writing upon the contractor.
 10. If the school desires to terminate this agreement and give the contractor one calendar months' notice in writing such desire and shall up to the time of such termination, pay the amounts due and perform and observe the covenants on his part herein before contained, then immediately on the expiration of such notice, this agreement shall be void but without prejudice to the remedies of either against the other in respect of any antecedent claim or breach of covenant.
 11. Any notice required to be served on the school or contractor under this agreement shall be deemed to have been served if delivered at or sent by registered post to the office of the school or licensee at the address (es) herein above specified or received by his representative in person at his office.
 12. The contractor shall not, without the written consent of the school, create a sub-contact of any description with regard to this agreement or any part thereof nor shall, without written consent as aforesaid, assign or transfer this agreement or any part thereof. The

contractor shall follow the instructions issued by the school from time to time regarding school transportation provisions including those provision, which may affect the time schedule and shall follow the instructions, so issued this matter, in accordance to conditions, so issued in this matter, in accordance to conditions specified in this contract.

13. The contractor shall employ only such servants, agents and employees as shall have good character and be well behaved and skillful in their business. The contractor shall furnish the school in writing with the names, percentage, age, residence, photograph and specimen of signature or thumb impression of all such servants, agents and employees (Fill the profile sheet for drivers and conductors dully countersigned by the owner, whom the contractor to employ under this agreement before they are so employed and the licenser shall be at liberty to forbid the employment for any person to whom he may considered undesirable. The contractor will provide the Driver profile sheet in respect of all drivers and the conductor profile sheet for all bus driver / conductors duly filled in the form of a folder. The servants agents, and employees employed by the contractor shall be under the general discipline of the school and shall confirm of such directions as may be issued by the school in respect of the use of toilets. The contractors shall have also character of all the persons employed by him verified by the Police to the satisfaction of the authority before employment and will provide a copy of police verification to the School Management at the at the time of signing of contact.
14. The contractor, its agents, employees and servants shall use the school's premises only for the purpose indicated in this agreement and for no other purpose whatsoever.
15. The contractor will, during the continuance of this agreement, insure against any claims for workmen's compensation or otherwise of all persons employed by him in connection with his business to be

carried on under this agreement as aforesaid with an insurance company and the contactor shall produce for inspection on demand by the school all policies in respect thereof and the receipts from time to time for current premium and further that the contactor shall ensure that all statutory / legal liabilities in respect of employees provided fund, ESI , etc. are catered to on his own accord and shall furnish the details in this matter, as and when needed by the school.

16. The contractor, its agent, employees and servants shall observe, perform and comply with all rules, regulations and statutory with all rules 1993 and any other statute including any rules and regulations of any local authority, in force from time and applicable to the business which the contractor is allowed to carry on under this agreement and to the area in which the contractor will operate under this agreement.
17. Deduction of tax at source as per income tax act and amendment from time to time and any other levy as enforced by any authorities will be made.
18. In the event of any default, failure, negligence or breach on the part of the contractor in complying with any of the conditions specified in this agreement and/ or any statutory provision applicable to the business carried on by the contractor the school will be entitled and be at liberty to determine this agreement forthwith and forfeit and forfeit in full or in
