The date of submitting the quotations has been extended up to **19/12/2018 by 4 P.M.**

The terms and conditions as under:-

- 1) The rates quoted should include all taxes, delivery charges and all other hidden cost, if any.
- 2) No extra payment shall be made to vendor at any circumstances then the quoted price.
- 3) No advance payment shall be made at any circumstance.
- 4) The quotation of only given specifications and specified company shall be accepted. Quotation of any other company and specifications shall be rejected.
- 5) On the top of the envelop it should be clearly mention "quotations for sports material and the same should be addressed to principal/DPPS.
- 6) The quotation should reach this office by 4 P.M
- 7) Quotation received late will not be entertained.
- 8) Incomplete or conditional quotation will not be entertained.
- 9) Rates quoted shall be valid upto one year from the date of last date of submission of quotations.
- 10) Payment will be made only after delivery and after assessing of specification of the items.
- 11) Vendor shall indicate their rates in clear/visible figures as well as in words and shall not overwriting/make cutting in the quotation. If any alteration/overwriting etc. are noticed, the rates of such item shall not be considered.
- 12) Conditional quotations shall not be accepted at any cost and shall be rejected straightway.
- 13) If there is any fault in any item, the same shall be changed by vendor, as soon as possible.
- 14) The committee decision will be final and the vendor should not have any objection in this regard.
- 15) All disputes are subject to the jurisdiction of the courts in the NCT of Delhi.
- 16) The delivery of items shall be made within 7 days of purchase order, failing which management reserves the right to cancel the order.
- 17) Decision of the management/purchase committee shall be final and binding.
